

CITY OF VERNON SPECIAL PARCEL TAX INFORMATION AND APPLICATION INSTRUCTIONS

The City of Vernon imposes an annual Warehouse Special Parcel Tax (Warehouse tax) and an annual Public Safety Special Parcel Tax (Public Safety tax). The Warehouse tax is levied on the square footage of land area utilized for warehousing, distribution, truck terminal, and freight terminal occupancies. The Public Safety tax is levied on the square footage of land area or portion thereof not taxable by the Warehouse tax. The Warehouse tax and the Public Safety tax are collected through the Annual Property Tax Bill.

The Warehouse tax assessment for <u>Fiscal Year 2020/2021 is \$0.33525</u> per square foot of gross land area. The Public Safety tax assessment for <u>Fiscal Year 2020/2021 is \$0.03457</u> per square foot of taxable parcel area. Please note the special parcel tax assessments may be increased annually.

Information relevant to the special parcel taxes is described in Chapter 5, Article IV, Section 5.45 and Section 5.46 in the Code of the City of Vernon https://codelibrary.amlegal.com/codes/vernon/latest/vernon_ca/0-0-0-1967.

If you wish to file for an adjustment, reassessment, exemption or an inquiry of the Warehouse tax and/or the Public Safety tax assessed on your parcel or business the City requires an Application for Adjustment/Reassessment/Exemption/Inquiry of the Special Parcel Tax to be completed and submitted to the City of Vernon. Please complete the application in its entirety and **submit an original signed application** to the Office of the City Clerk. The Public Works Department staff will conduct the investigation of your claim.
