Dear Mr. Wagner:

This letter provides approval of the Early Action Reduction Plan submitted by Sterigenics US, Inc. (Sterigenics Vernon) pursuant to South Coast Air Quality Management District (South Coast AQMD) Rule 1402.

South Coast AQMD staff sent you a letter on June 7, 2022 designating Sterigenics Vernon as a Potentially High Risk Facility under Rule 1402. As detailed within the letter, the submittal of an Early Action Reduction Plan within 90 days of the date of designation is required under Rule 1402 (g)(2). The Early Action Reduction Plan submitted on September 2, 2022 has been reviewed by South Coast AQMD staff and has been found to meet the requirements outlined in Rule 1402. Compliance with the terms of this approved Plan is now required by South Coast AQMD Rule 221 and Rule 1402(g)(2)(C).

As detailed in the designation letter, Sterigenics Vernon is also required to submit an Air Toxics Inventory Report (ATIR), a Health Risk Assessment (HRA), and a Risk Reduction Plan (RRP) no later than the timelines outlined below:

Please note that the RRP will need to include risk reduction measures to reduce the impact of total facility emissions below the Action Risk Level as quickly as feasible. Additional risk reduction measures beyond those specified in the Early Action Reduction Plan may be needed to account for updated information on facility emissions and health risks as they become available.
