Assembly Bill ("AB") 361, signed into law on September 16, 2021, amends Government Code section 54953 to provide authority and specific requirements for public agencies to hold virtual meetings during a proclaimed state of emergency and remain in compliance with the Brown Act (Gov. Code §§ 54950 et seq.).

Consistent with mandates of AB 361, some, or all, SEWC Board Members may attend this meeting virtually. A physical location from which members of the public may observe the meeting or offer public comment will not be made available. Vernon City Hall will not be open to the public for this meeting; however viewing and public comment options are provided below.

4. PFOA / PFOS PROPOSED CERCLA DESIGNATION

Chelsea E. O'Sullivan, Richards, Watson, and Gershon Recommendation: That the Board take the following action:

Receive and file an update on the Environmental Protection Agency's (EPA) proposed addition of PFOA and PFOS to the list of CERCLA contaminates. Also review HR 2467, a House bill that would add PFOS and PFOA to the list of CERCLA hazardous substances in lieu of action taken by the Federal EPA.

5. AB1931 – COMMUNITY WATER SYSTEMS – LEAD SERVICE LINES - UPDATE

Joanna Moreno, AE Chair, City of Vernon Recommendation: That the Policy Board take the following action:

Receive and file an update on AB 1931, Community water systems – lead service lines.

At their August 4, 2022 meeting, the Board voted to send a letter in Opposition to AB 1931. On August 11, 2022 the bill was placed in a status of "Held under submission" in the Senate Appropriations committee. This "Held under submission" status resulted in the bill being dead for the legislation session that ended August 31st. The bill can be reintroduced in January 2023, though if it is it must begin the whole legislative process again.

Because AB 1931 was placed in the "Held under submission" status less than one week after the SEWC Board's meeting, no letter of opposition was sent.
