- 3. Total project costs (parts & labor) with final paid invoices.
- 4. Completed W-9 form (VPU Customer).
- New Equipment Specification Sheet(s) from the manufacturer.

### Participant Agreement Clause (please read carefully):

VPU Customer agrees to submit a complete application within 180 days from the date of purchase. Customer agrees to provide VPU with site access to verify existing equipment prior to the installation (if necessary), and a follow-up visit after the proposed efficiency measures are installed. Customer agrees to provide an itemized and paid proof of purchase (invoice) upon project completion. The maximum rebate provided by the Commercial Energy Rebates Program shall not exceed \$25,000 or 50% of the total project cost (whichever is less), in any given VPU fiscal year. The final rebate amount will be calculated based on the incentive amounts in effect at the time of application approval. VPU may withhold payment until program requirements are met; rebates are subject to the availability of funds.

I hereby certify that I am the Customer of Record or that I am authorized to enter into this agreement by the Customer of Record.
