- 2. Annual estimated energy savings resulting from the retrofit listed as annual kW and kWh savings.
- 3. Total project costs (parts and labor) with paid invoices.
- 4. Completed W-9 form (VPU Customer)
- 5. New Equipment Specification Sheet(s)

VPU Customer agrees to complete the proposed project within 180 days from the pre-inspection date listed on Page 2, it is the sole responsibility of the Customer to submit an extension request to VPU for approval (if applicable). Customer agrees to provide VPU with site access to verify existing equipment prior to the installation, and a follow-up visit after the proposed efficiency measures are installed. Customer agrees to provide an itemized and paid proof of purchase (invoice) and a post-installation application form upon project completion. The maximum rebate provided by this Program shall not exceed \$50,000 or 50% of the total project cost (whichever is less), in any given VPU fiscal year. The final rebate amount will be calculated based on the incentive schedule in effect at the time of application approval. VPU may withhold payment until program requirements are met; rebates are subject to the availability of funds.
