Residential EV Charger Incentive Program (REVSE): Terms and Conditions

- 1. Vernon Public Utilities (VPU) residential electric customers are eligible for up to \$2,500 in rebates, when a new, "Wi-Fi enabled" or "Internet Connected", Level 2 EV Charger is installed at the customer's residence.
- 2.All electrical work must be performed by a qualified and licensed contractor in accordance with local codes, permitting, and inspection requirements.
- 3.All Level 2 EV Chargers must be new, with "Wi-Fi enabled/Internet Connected" features.
- 4.EV Chargers that are portable, leased, resold, rebuilt, received from warranty insurance claims or won as a prize are not eligible for rebates under this Program.
- 5.Level 2 (240V) EV Chargers must be equipped with the SAE J1772 standard or Tesla connector plug, and certified by a nationally recognized testing laboratory (NRTL).
- 6.All Level 2 (240V) EV Chargers must be wall-mounted or pole-mounted at the electrical service address provided in the rebate application.
- 7. Submit your REVSE incentive application within **180 days** from date of purchase.
- 8.An electrical permit from the City of Vernon's Building Division is required for the installation of a hard-wired EV Charger or new/modified 240V power socket. Applicants that utilize an existing 240V power socket are responsible to ensure the existing socket is compatible with the charger plug type and loading requirements if unsure, check with a licensed electrician.
- 9.To apply for an electrical permit through the City of Vernon's Public Works department (Building Division), please call 323-583-8811 or visit the Online Permit Center.
- 10. An existing or new 240V outlet is NOT eligible for incentives under this Program.
- 11.EV Chargers that allow the user to switch between Level 1 (120V) and Level 2 (240V) charging are NOT eligible for incentives under this Program.
- 12. The EV Charger incentive is limited to two (2) chargers per residential address.
- 13.VPU reserves the right to perform an on-site inspection, as part of the application review process.
- 14. The rebate will be based upon the actual cost of the EV Charger. Incentives received from other parties/agencies should be subtracted from the unit before applying for the Program.
- 15.Under no circumstances shall the rebate amount exceed the cost of the EV Charger equipment, cost of installation and permit fees.
